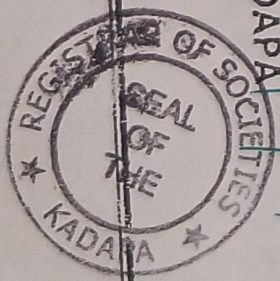

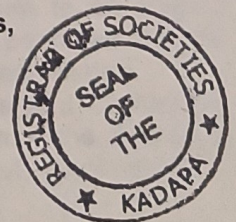

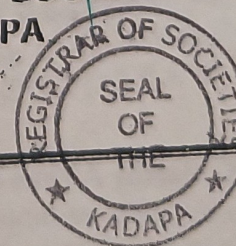

15. Income Tax Exemption Act 1961

- a) The funds of the Mahila Mandali would be invested as per section 11 (5) of the I.T. Act, 1961.

- c) The accounts would be maintained regularly and would be audited by a Chartered Accountant.
- d) The funds of the Mahila Mandali would be utilized only towards the objects and to no portion of it would be distributed in any manner to the Trustees or persons defined in section 13 (1) (c) of the I.T. Act, 1961.
- e) In the case of winding-up/ dissolution the net funds would be transferred to other institution having similar objects and enjoying exemption U/S. 12A and 80-G of the I.T. Act, 1961.
- f) The benefits of the objects would be available to the General Public irrespective of Caste, Creed, Religion or Sex etc.,
- g) The Mahila Mandali will not make any Amendments to the clause of the Memorandum of Article or Deed without the written permission of the Commissioner of Income Tax.
